## Privacy statement

### Protection of personal data

We take the privacy of personal data very seriously. With the new privacy law 'General Data Protection Regulation' (GDPR), data is better protected and that is a good thing. Nobody wants to receive unwanted e-mail. In accordance with the General Data Protection Regulation Hellas Greek LifeStyle Travel has the obligation to provide information on which personal data is collected by our website. This privacy statement contains everything about the personal data that is processed through our website and our contact forms.

When you register with Hellas Greek LifeStyle Travel, you have to take the following into account and give your explicit permission for this;

### General

On this page you will find the privacy statement of Hellas Greek LifeStyle Travel. You are advised to carefully read this privacy statement before continuing on our website.

Hellas Greek LifeStyle Travel is a company to be and is in it's investigation period as a Start Up to be. As soon as we can start, we will registrate our company in the chamber of commerce and will complete the registration number into this privacy statement as soon as possible. Hellas Greek Lifestyle Travel can be contacted by e-mail on [info@hellasgreeklifestyletravel.com](mailto:info@hellasgreeklifestyletravel.com) and also for questions about the privacy statement.

This privacy statement explains how Hellas Greek LifeStyle Travel handles the processing of your personal data. Hellas Greek LifeStyle Travel attaches great importance to the proper protection of such data and to inform you as well as possible about this. For example, it indicates which (categories of) personal data are collected and for what purpose the personal data are used. Hellas Greek LifeStyle Travel also indicates which legal basis is the basis for the processing of personal data.

This privacy statement applies to all visitors to our website. If you do not agree with this privacy statement, you must leave the website. The processing of personal data by Hellas Greek LifeStyle Travel falls within the statutory exemption regulations. For this reason, the processing is not registered with the Dutch Data Protection Authority.

Hellas Greek LifeStyle Travel reserves the right to change this privacy statement. The current privacy statement was last updated on 23 May 2018.

### Forms, types, goals, legal grounds and time limit for processing personal data

In the first place, personal data are processed when you fill in the registration forms by yourself on our website like the 'Stay Informed' form and the 'Contact for Collaboration' form. When you fill in these forms, you also agree with our privacy statement.

When filling in the 'Stay Informed' form your name and e-mail address will be asked. This is necessary to contact you, but is also used to inform you in the future about our progress as a Start Up company, news, certain services that may be of interest to you and to send you valuable information. This form is connected with the email tool Active Campaign.

We only keep you informed when you actively register or has registered for this on the forms on our website. This means that you will not receive news and information if no explicit and active registration has taken place. As soon as you have registered, the e-mail address along with the date of registration and various technical data is stored in a safe environment, at least according to standards of reasonableness-protected environment.

When filling in the 'Contact for Collaboration' form then in addition you fill in your first name, your last name, your function in your company, your telephone numbers and email where we can reach you for contact, the address, the place, the type of accommodation/service and it's special characteristics. There is space for questions/remarks, a proposal how we can get to know you and your accommodation/services. You also can upload a link with information about your accommodation/services if you want, so we can have a first impression about your accommodation/services and to see if we can and may use this in a later stage on our website in the future, off course due a separate following procedure.

Only you personally and independently can leave your data active on our website, and later on (because we still working on our website at this moment) also maybe in a web shop and on social media channels. This data during this process will only be used for the purpose for which they were left behind.

It is possible that data are included in our database because they are obtained through a different channel than our website. This could include contact by telephone, WhatsApp, e-mail, social media or a third party. In the aforementioned cases, too, the information actively provided by the person concerned will only be used for the purpose for which they were left behind.

The personal data is stored not longer then strictly necessary and is for the purpose for which the data has been left active by the data subject. It also applies that for the processing of (personal) data only those data are used that the person concerned has actively left behind.

Our goal is to keep in contact with each other.

Our website does not intend to collect data about website visitors who are younger than 16 years. Unless they have permission from parents or guardians. However, we can not check whether a visitor is older than 16. We recommends that parents are involved in the online activities of their children, in order to prevent data about children being collected without parental consent. If the person concerned is convinced that we have collected personal data about a minor without this permission, please contact [info@hellasgreeklifestyletravel.com](mailto:info@hellasgreeklifestyletravel.com) and we will remove this information.

When we will start our company officially, we then will inform additional to this privacy statement but to inform you in advance, the personal data will be stored certainly for a period of time during the contract that we will closing with you, if you want a collaboration with us now or in the future. In addition, additional personal data will be processed in case of settlement of a payment. This will include name, first name, telephone number, address and bank account number. Hellas Greek LifeStyle Travel will then also processes personal data if we are legally obliged to do so, such as information that we need for our tax return. The above data is stored for five (5) and seven (7) years on the basis of the legal storage obligation. The legal basis for the processing of your personal data is because this is necessary for the execution of the agreement. Without your name and e-mail address Hellas Greek LifeStyle Travel can not contact you. In addition, Hellas Greek LifeStyle Travel is obliged to process this data in the event of invoices and tax returns. If you do not want to provide personal information to Hellas Greek LifeStyle Travel, than we are unable to provide the services to you. This means that Hellas Greek LifeStyle Travel can not meet the contractual, legal and necessary

obligations. Any adverse consequences due to the non-provision of the personal data will lie with you in such a case.

### Cookies

Hellas Greek LifeStyle Travel uses cookies on its website to ensure that we give you the best experience on our website. If you continue to use our website we will assume that you are happy with it. Hellas Greek LifeStyle Travel uses at this moment cookies only to improve the website, which are also called functional cookies. For further explanation about cookies, see their website.

What are cookies? A cookie is a piece of data that a website places on your computer, tablet or smartphone on the first visit to a website. Every time you visit our website, it collects basic technical information. This ensure that the website works properly.

We are still working on our website, so by expanding of our pages it can change besides functional only into analytical and tracking cookies too. At that time we will adjust this on this privacy statement form. So we inform you in advance. If then we decide to records data about the use of this website, then data includes visitor numbers, visited pages and properties of the web browsers used. With this information we can improve the website and adapt it to the wishes of the user. Cookies can be used in this. Cookies then are placed on your computer or telephone for the anonymised use of Google Analytics. The personal data then will be for internal use and are not passed on to other organizations for commercial purposes.

Cookies are also placed on website by third parties. Our email tool Active Campaign who connects with the 'keep me informed' form on our website is using cookies, so we can see your activity, such as keep track of which website pages you have visited. It collects your email address IP address. For their cookies policy please visit their website.

### Reference to other websites

This privacy statement only applies to this website and subdomains of this website.

We still are working on our website. It may be that this website later on will contain links to other websites that are not managed and/or are not owned by Hellas Greek LifeStyle Travel. If you have reached another website by clicking on that particular link, the privacy statement of the relevant website applies. Hellas Greek LifeStyle Travel is in no way liable or responsible for that website or for the privacy statement on that website. Hellas Greek LifeStyle Travel recommends that you read that particular privacy statement carefully when you visit the website before continuing on that website.

### Transfer to processors and third parties

Your personal data will be processed by companies that are or will be called in by Hellas Greek LifeStyle Travel for the execution of the agreement and to comply with any legal obligation. Such companies are also called 'processors'. Think of a company that takes care of the invoicing (when starting), hosting, system management/security, email. They will act exclusively under the responsibility of Hellas Greek LifeStyle Travel. It concerns the following processors:

- Active Campaign:

For sending e-mails with information about the purchased product. Your personal data is stored on a server outside the Netherlands, namely in the United States. They have an active certification for the

EU-U.S. Privacy Shield in order to transfer safely any lawfully obtained personal data to the services of Active Campaign and hereby they are GDPR compliance according the Dutch Data Protection Authority. You can find more details about their Privacy Shield Certification on their own website.

- KPN Internetservices:

Our hosting company for our WordPress website and our domain names is based in the Netherlands Our website is on their server in the Netherlands.

- Mijn Bedrijf Zichtbaar Online:

The company who has built our website and takes care of the maintenance on the website is based in the Netherlands.

With the above companies we conclude a processor agreement to ensure the same level of security and confidentiality of your data. Hellas Greek LifeStyle Travel remains responsible for the processing carried out by these companies.

Your personal data will only be shared with third parties, not being processors, if Hellas Greek LifeStyle Travel is obliged to pass on personal data to competent authorities on the basis of a legal obligation.

### Security

Hellas Greek LifeStyle Travel has taken appropriate technical and organizational measures to protect your personal data against loss or unlawful processing.

The website has an SSL certificate, so that the data is sent over a secure connection. Information provided through our website shall only be transmitted with an encrypted secure SSL connection, so that a third party can not intercept the data to be sent or receives. You can recognize the active secure connection through a visible 'lock' at the top of the address bar of the web browser and it's HTTPS status.

We also have a Word Press all in one security against hackers. Off course we have an antivirus system in general on our computers too.

In advance of expansions of our website, on which we are working now, we aim to provide a safe environment for every visitor, also when we will outsource parts relating to payments in the future.
